Operated by the Homeless & Housing Coalition of Kentucky (HHCK), the mission of the Homes for All program is to provide housing-related services to individuals and families across Kentucky who are experiencing homelessness, housing insecurity, or in search of affordable homeownership opportunities.

Supportive Housing: HHCK provides a range of medium-term to permanent supportive housing vouchers for individuals and families experiencing homelessness within 118 counties in Kentucky (all except Fayette and Jefferson). Eligibility and priority are determined only through the Coordinated Entry process.

Housing First Program: A permanent rental assistance voucher program targeted specifically towards Kentuckys homeless individuals and families.
